It was a pleasure to hear from a member of the Reeves family after so many years. It so happens I was the vice president in charge of broadcast advertising on the Chevrolet account during 1965 when we selected the North Carolina coastal area as the location for our 1966 Chevrolet announcement advertising. We are in the process of collecting whatever advertising materials still on hand and will make them available to you.

During the mid-60's Chevrolet advertising was based upon the theme "See the U. S. A." and we selected various locations throughout the United States that were unique and symbolized the great variety of terrain in this country -- places like the Great Smoky Mountains; the North Carolina seashore; Niagara Falls; Yosemite, as well as other National Parks; the Golden Gate Bridge; the Delta country; and desert areas were among the selected locations. We filmed some twenty commercials in the area from Asheville to the North Carolina coast. Naturally, in automotive commercials the car is featured, but we like to leave viewers with an appreciation of the background scenery. Strangely enough people write and ask where a certain commercial was filmed. This was the case regarding the Carolina coastal filming since we received a number of requests asking for the lighthouse, beach and Fort Mason location.



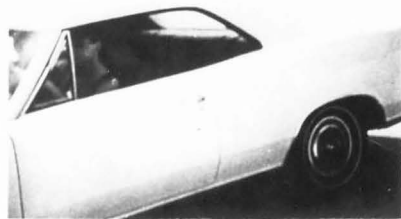
