Being the only permanent residents on Cape Lookout and Core Banks, and having been for the past four years, we believe we have the right to let the public know a few facts.

The State of North Carolina will do the people of this State a great injustice if they turn these Outer Banks over to the Federal Government, as its possibilities are unlimited. A few years ago, who would have put any value on the swampy coast of southern Florida ? The coast of Florida cannot compare with these Outer Banks, and our climate out here is very close to that in northeastern Florida.

If the State were to turn these Banks over to the Federal Government, we still do not have any assurance that the Federal Government will follow through with the program which the Outer Banks Seashore Park Commission has proposed. It is the consensus of opinion of the U.S. Army Engineers, that if the restoration of the Outer Banks were an Army Engineers project, then it would be vetoed. According to their records, the Banks are not as depleted as they have been in the past.

Assuming that these Banks are turned over to the Government, and that they do put dredges on the inside and pump in a dune; then what ?




